It is hereby informed to all ex-trainees under Craftsman Training Scheme (CTS) pertaining to sessions till 2022¹ and concerned stakeholders that migration of the NCVT MIS data to the Skill India Digital Hub (SIDH) portal is currently under process.

- 2. Provision to raise profile grievances and tickets for all ex-trainees under Craftsman Training Scheme (CTS) pertaining to sessions till 2022¹ shall be available on the NCVT MIS portal only until 15th September, 2025. After this date, no grievance or correction/updation request shall be entertained on the NCVT MIS portal through any means, and the portal's data shall be considered frozen.
- All concerned ex-trainees, institutions, and other stakeholders are strongly advised to take note of this
 timeline and ensure submission of any pending profile-related grievances or tickets before the
 aforementioned deadline.
- Subsequent to this, provisions to raise grievances and tickets for such legacy trainees will be made available on SIDH portal following completion of data migration, tentatively by 15th October, 2025.
 Relevant instructions regarding new grievance and ticketing processes on SIDH portal will be issued in due course.
